This product is acceptable for use in inedible product processing areas, nonprocessing areas, and/or exterior areas of food processing establishments (C1) provided that it is not used to mask odors resulting from unsanitary conditions, and that any characteristic odor or fragrance does not penetrate into an edible product area. When used on equipment that will be returned to a food processing area, the product must be completely washed off and rinsed with potable water before returning to the processing area.

This product is acceptable for use in toilets and/or dressing rooms of food processing establishments (C2) where edible products are neither processed or stored in open containers, provided that it is not used to mask odors resulting from unsanitary conditions, and that any characteristic odor or fragrance does not penetrate into an edible product area. If used on equipment that will be returned to a food processing area, the product must be completely washed off and rinsed with potable water before returning to the processing area.

This product is acceptable for use as a sanitizer on all surfaces always requiring a rinse (D1) in and around food processing areas. Before using this compound, food products and packaging materials must be removed from the room or carefully protected. A potable water rinse is always required following the use of this compound. The compound must be used in a manner which does not result in the contamination of food products subsequently processed and must be consistant with the directions on the EPA registered label.
